

# EqualiTeach E-Learning Terms and Conditions

# Supply

EqualiTeach's online course provision is hosted on its Empowered website, designed in WordPress.

EqualiTeach endeavours to supply clients with the highest quality products and services as described on our websites, promotional material and/or sales proposals.

Any changes in the services, products or other elements quoted for or agreed will become effective only upon written agreement of each party. The client will provide EqualiTeach in a timely manner all assistance and information which EqualiTeach may reasonably request for the performance of the services. EqualiTeach will not be liable for delays in the performance of services caused by delay or failure to provide this information to EqualiTeach.

#### Registration

Clients will be registered for EqualiTeach e-Learning courses once a registration form is submitted and, for charged courses, once payment has been received.

All information provided by the client must be true and accurate at the point of registration. In the event of a change of circumstances such as number of users registered, phase of education or change of contact details, the client must notify EqualiTeach by email or in writing so that our records are up to date.

Unless otherwise agreed with EqualiTeach, all users will have access to the course and any associated resources for 30 days from the point of payment, or registration if courses are provided free of charge.



Group registrations can be made on behalf of a group of schools or organisations, for example, by a Multi-Academy Trust, a Teaching School Alliance or other group. In the case of group registration, each school or organisation would have a lead person, who sets up an account and then shares that with their colleagues with the url provided in their Account page.

# Payment and Cancellation

Charges for the services will be as described in the relevant quotation (either on the EqualiTeach website or in a sales proposal) and amendments subsequently agreed in writing. Unless otherwise agreed between the parties in writing, clients must pay in advance of the service by EqualiTeach to the client.

All payments are due upon registration onto the e-learning platform. Individual payments will be processed online via Stripe. Group registrations will be invoiced.

Invoices are due to be paid within 30 days from the date of invoice. Payment may be made via BACS (direct bank transfer) or cheque.

Please note that EqualiTeach products and services attract VAT. This will be clearly stated.

## Cancellation of Orders

The client has the right to cancel their order should EqualiTeach read the Terms and Conditions of the sale.

## Termination of Contract

EqualiTeach reserves the right to withdraw registration if the client puts the organisation into disrepute.

#### **Intellectual Property**



Unless otherwise stated, all intellectual property rights for all materials of EqualiTeach online courses, promotional materials and all other communications belong to EqualiTeach.
